**Notice of emergency meeting to be conducted by  
the Tohopekaliga Water Authority Board of Supervisors**

**Kissimmee, Fla. (Friday, March 19, 2021)** - Please be advised that the Board of Supervisors of the Tohopekaliga Water Authority, an independent special district, established and created pursuant to Chapter 189, Florida Statutes, by special act of the Florida Legislature, hereinafter "Toho", plans to hold an emergency meeting on Wednesday, March 24, 2021, beginning at 5:00 PM in the Bruce R. Van Meter Board Room located on the first floor of the TWA Administration Building, 951 Martin Luther King Blvd., Kissimmee, Florida 34741.

The purpose of this special meeting is to consider the settlement agreement in the Central Florida Water Initiative ("CFFWI") rule challenge consolidated proceeding Seminole County, et al. v. FDEP, et al; Division of Administrative Hearing ("DOAH") Consolidated Case No. 21-000791RP.

All persons interested are invited to attend and any person deciding to appeal any decision of the Tohopekaliga Water Authority Board of Supervisors with respect to any matter considered at this special meeting will need a record of the proceedings. For such purpose, he/she may need to ensure that a verbatim record of the proceedings is made, which record includes the testimony and evidence upon which the appeal is to be based.

Due to social distancing practices in response to the COVID-19 pandemic, limited seating will be available for the public. Social distancing and safety measures will be enforced. Safety measures include face coverings and temperature checks, both of which are required to enter the Toho Administration Building. Facial coverings will be required at all times, with the exception of when an individual is at the podium addressing the Board or while seated on the dais. Board Room audience seating will be limited to approximately 12 socially distanced seats. Public seating in the Board Room will be subject to reservations made at least 24-hours in advance of the meeting, with additional seating available in the lobby on a first-come, first-serve basis.
